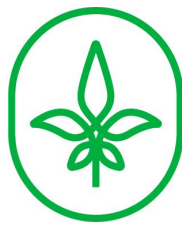

TERMS AND CONDITIONS

It is expressly agreed that the following terms and conditions are an integral part of any order and purchase made by the client from **GROUPE LA FEUILLE VERTE INC.** (hereinafter referred to as "LFV"). The client acknowledges having read the terms and conditions and, by placing an order, confirms his acceptance of such conditions and stipulations.

- CANCELLATION** – A duly placed order cannot be cancelled by the client. LFV reserves the right to cancel all or part of an order placed by the client for any reason whatsoever.
- PAYMENT CONDITIONS** – Unless expressly agreed otherwise, the client must pay of any amount due within a maximum of 30 days of the invoice date. The amount of any sum due shall be paid without abatement, offset or compensation of any nature whatsoever.
- INTEREST** – Any amount due to LFV that is not paid at maturity will bear interest at 18% per annum (1.5% per month).
- APPLICATION OF PAYMENTS** – LFV will apply any payments received first to interest due, if any, and then to unpaid invoices to the client's account, from the oldest to the most recent.
- CANCELLATION OR REDUCTION OF THE CREDIT LIMIT** – LFV may at any time cancel the credit limit granted hereunder, and require the client to pay in advance for any order or purchase made, for any reason whatsoever, at its sole discretion. LFV may also, at its discretion, reduce the credit limit granted. In the event of the cancellation or reduction of the credit limit, the client and any guarantor shall nevertheless remain bound by other terms provided for herein, which shall continue to apply, with the necessary modifications, to any subsequent order.
- COLLECTION FEES** – The client shall be responsible for paying all legal collection fees in connection with any overdue account, including, without limitation, court fees, reasonable legal fees and expenses, as well as any other charges or expenses incurred by LFV for the collection of its amount receivable, all such amounts being due and payable upon receipt of an invoice to that effect.
- TRANSPORT RISKS** – LFV will assume the risks of breakage and loss until the products are received by the client. However, the client is responsible for inspecting the products received and any damage or loss resulting from transport must be reported to LFV by the client within a maximum of ten (10) days of receipt of the order.
- LIABILITY** – It is expressly agreed between the parties that LFV's liability is limited and may not exceed the price of the order.
- AUTHORIZATION** – The client agrees that LFV may verify any source of public or private information, both concerning the client's company and its officers, for any reason deemed relevant by LFV in the context of its business relationship. Without limiting the generality of the foregoing, the client authorizes LFV and its representatives to contact the references and the financial institution described herein and to collect from them any information deemed useful in connection with this account opening application. The client hereby expressly authorizes all such persons, entities or institutions to make such information available, releasing them from any liability in this regard. This authorization will remain valid throughout the business relationship between the client and LFV.
- APPLICABLE LAWS AND ELECTION OF DOMICILE** – These terms and conditions, as well as any other contract, agreement or purchase entered into or to be entered into between the client and LFV, shall be interpreted and governed in accordance with the laws in force in the province of Quebec and the laws of Canada that are applicable. The client agrees and accepts, for any motion or legal action for any reason whatsoever between the parties and in connection herewith, to choose the judicial district of Drummond as the appropriate place for the hearing of such motions and legal actions, to the exclusion of any other judicial district that may have jurisdiction in such a situation in accordance with the law.
